### Directions to Shows • Must Read

Featherly Regional Park • Canyon RV Park is conveniently situated on the northwest corner of the 91 Freeway and Gypsum Canyon Road in Anaheim, California.

**From the west:** Traveling eastbound on the CA-91 Fwy, pass Weir Canyon Road. Take Exit 41 for Gypsum Canyon Road. Turn left at the bottom of the off-ramp. Pass under freeway and turn left at the signal. This will lead you right into the entrance. Specialty location is to the right after entering park.

**From the east:** Traveling westbound on the CA-91 Fwy toward Beach Cities, pass Green River Road. Take Exit 41A for Gypsum Canyon Road. At the bottom of the off-ramp continue straight through the signal into the park entrance. Specialty location is to the right after entering park.

**Day of show parking:** Close to rings. \$5.00 per vehicle. Park in the lot across the road. **Do not park along the edge of the roadway or on the grass.**
